COMPLAINT AND INFORMATION

IN THE NAME AND BY THE AUTHORITY OF THE MUSCOGEE (CREEK) NATION comes now Justin Valentine, the duly qualified Prosecutor, within and for the Muscogee (Creek) Nation, and upon his oath of office gives the District Court of the Muscogee (Creek) Nation, to know and be informed and complain that defendant **Anthony Dillard**, an Indian person, did, within the jurisdiction of the Muscogee (Creek) Nation, on or about the 31<sup>st</sup> day of May, 2021, anterior to the presentment hereof, commit the following crime(s) in the manner and form as follows:


COUNT ONE: INDECENT EXPOSURE (MCNCA Title 14, § 2-317(A)) That said Defendant within the Muscogee (Creek) Nation on the day and year aforesaid did knowingly expose his person or genitals in a public place or any place where others are present to be offended or annoyed thereby, to wit: defendant did expose himself lewdly to victim J.M. at J.M.'s place of work.

This crime is a felony punishable by imprisonment for up to three (3) years and/or a fine of not more than fifteen thousand dollars (\$15,000.00).

COUNT TWO: INDECENT EXPOSURE (MCNCA Title 14, § 2-317(A)) That said Defendant within the Muscogee (Creek) Nation on the day and year aforesaid did knowingly expose his person or genitals in a public place or any place where others are present to be offended or annoyed thereby, to wit: defendant did expose himself lewdly to victim G.G. in the parking lot of G.G.'s place of work.

This crime is a felony punishable by imprisonment for up to three (3) years and/or a fine of not more than fifteen thousand dollars (\$15,000.00).

Contrary to the form of the laws in such case made and against the peace and dignity of the Nation.






