COMPLAINT AND INFORMATION


IN THE NAME AND BY THE AUTHORITY OF THE MUSCOGEE (CREEK) NATION comes now David Pierce, the duly qualified Prosecutor, within and for the Muscogee (Creek) Nation, and upon his oath of office gives the District Court of the Muscogee (Creek) Nation, to know and be informed and complain that defendant **Angel Watashe**, an Indian person, did, within the jurisdiction of the Muscogee (Creek) Nation, on or about the 2nd day of October, 2021 anterior to the presentment hereof, commit the following crime(s) in the manner and form as follows:

COUNT ONE: DOMESTIC ABUSE BY STRANGULATION (MCNCA Title 14, § 2-303(G))

That said Defendant within the Muscogee (Creek) Nation on the day and year aforesaid did unlawfully commit an assault and battery with the intent to cause great bodily harm by strangulation or attempted strangulation against a person with whom the Defendant was in a domestic relationship with, to wit: Defendant choked his grandmother, Debra Watashe causing her to gasp for air.

This crime is a felony punishable by imprisonment of not less than one (1) year nor more than three (3) years and/or a fine of not more than fifteen thousand dollars (\$15,000).

Contrary to the form of the laws in such case made and against the peace and dignity of the Nation
