Principal Duties and Responsibilities:	<ul style="list-style-type: none"> • Direct activities of workers concerned with a specific trade on construction projects, remodeling, new construction and service work for all tribal projects. • Install, maintain, and enhance electrical systems and components, including fuses, lights, and wiring. • Perform all work in a manner that meets and follows electrical codes, blueprints, and standards. • Inspect, test, and diagnose issues with electrical systems and components. • Ensure adequate inventory of necessary supplies and parts. • Calibrate equipment to provided specifications. • Perform preventative maintenance on electrical systems and components. • Troubleshoot problems and make timely repairs. • Attend training as needed. • Other duties as assigned by management.
