A. This certificate is most commonly known as a **Certificate of Good Standing** or a **Certificate of Existence** and is usually issued by the Secretary of State's office. This certificate **must** be issued within the last **60 days**.

B. The name under which a foreign limited partnership may register **shall** include the words **LIMITED PARTNERSHIP** or the abbreviations **L.P. or LP** (Title3, Section 2-303)

C. If the name of the foreign limited partnership does not satisfy the statutory requirements as set out in paragraph "B" of this form **or** if the name of such partnership is not available for use in the Muscogee (Creek) Nation, a statement by its general partner duly adopting a fictitious name that is available, and/or which does satisfy the statutory requirements, **MUST BE ATTACHED HERETO**. Such fictitious name shall be used to the exclusion of the partnership's true name when transacting business in the Muscogee (Creek) Nation. (Title 3, Section 2-352)
