Receive, review and summarize bids. Maintain bid and contract files. 4. Prepare and deliver presentations to contractors, management, and general public when necessary. Explain the contract process to prospective contractors and establish a working relationship with contractors. 5. Maintain a current database of qualified and approved contractors and vendors. 6. Enter contractor payments in the tenant accounting system. 7. Process change orders or contract modifications. 8. Supervise and guide the Contract Services Specialist in the day to day operations. 9. Compile information for monthly, quarterly and yearly reporting. 10. Perform any other duties as assigned.

MCN Policy Requirements:

All applicants must pass a drug test before beginning work. Any candidate who fails or refuses a drug test shall be withdrawn from employment consideration.

Medical Marijuana License Holder Protection and Non-Discrimination

A. Unless a failure to do would cause The Muscogee (Creek) Nation to imminently loose a monetary or licensing related benefit under federal law or regulations and with the exception of employees whose jobs are safety sensitive or primary job function is driving, The Muscogee (Creek) Nation shall not discriminate against a person in hiring, termination, or imposing any term or condition of employment or otherwise penalize a person based upon either: a. Solely, the person's status as a medical marijuana license holder; or b. Solely, the results of a drug test showing positive for marijuana and its components. B. Employees that are medical marijuana card holders shall not use, possess or be under the influence while at their place of employment or during hours of employment.
