General Summary:	As a member of the Administrative Staff of assigned facilities within the Elderly Nutrition Program, the purpose of this position is to provide oversight and direction to ensure smooth operations at the ten (10) Elderly Nutrition Centers located within the Muscogee (Creek) Nation. The position plays a critical role in ensuring the efficient operation in providing direct meal services to the elder citizens of the community served
Principal Duties and Responsibilities:	<ol style="list-style-type: none"> 1. Monitor sequence of operations and the priority of work production for each nutritional site, interview and recommend selection of food service workers, initiates disciplinary actions and performance requirements. 2. Supervise, schedule and coordinate the menu planning, food production and service, safety and sanitation, space and equipment and day-to-day operations of each nutrition center facility. Ensures that established sanitation and safety standards are maintained. 3. Oversees inventory controls, forecasting and the purchasing of foods, supplies and equipment. 4. Prepare and maintain work schedules for Roving Cook and kitchen staff. Oversees timekeeping and attendance records for ENP kitchen staff. 5. Ensure efficient operation of the 10 nutrition facilities. Makes site visits to each nutrition center on a regular and frequent basis. Monitor day-to-day operation of each facility, identifying problem areas and taking corrective action. 6. Coordinates and provides hands-on training programs for the development of the food service staff designed to increase professional knowledge and experience, as necessary. 7. Maintain required reports and data, and ensure they are provided to germane parties in a timely manner. 8. Responsible to the Program Manager and Food Services Director in accordance with the ENP and MCN policies and procedures. 9. Responsible for attending and participating in any training, workshops, and/or conferences as necessary. 10. Regular attendance is required. 11. Performs other duties as required.

A. Unless a failure to do would cause The Muscogee (Creek) Nation to imminently loose a monetary or licensing related benefit under federal law or regulations and with the exception of employees whose jobs are safety sensitive or primary job function is driving, The Muscogee (Creek) Nation shall not discriminate against a person in hiring, termination, or imposing any term or condition of employment or otherwise penalize a person based upon either: a. Solely, the person's status as a medical marijuana license holder; or b. Solely, the results of a drug test showing
