Renders written reports on progress of the students for whom they are responsible. 3. Responsible for maintaining proper behavior and conduct in and out of the dormitory. 4. Transport students as needed. 5. Shall supervise in gymnasium and at multi-purpose field as required. 6. Wake students so they can begin their day with breakfast, details, and preparing to catch the bus to school. 7. Help plan, organize, and supervise recreational activities. 8. To assist students in the school cultural enrichment program. 9. Supervise fire drill; supervise in storm warnings or storms. 10. Practice first aid. 11. Maintain quiet study hours and rest period, make evening bed checks, see that cleaning material and equipment are properly stored and cared for. 12. Make sure the child's clothing is conducive to the outside weather and dress code at dorm and public school is not abused. 13. Be willing to work rotating shifts. 14. Be willing to work weekends/some holidays. 15. Other duties as assigned.

MCN Policy Requirements:

All applicants must pass a drug test before beginning work. Any candidate who fails or refuses a drug test shall be withdrawn from employment consideration.

Medical Marijuana License Holder Protection and Non-Discrimination

A. Unless a failure to do would cause The Muscogee (Creek) Nation to imminently loose a monetary or licensing related benefit under federal law or regulations and with the exception of employees whose jobs are safety sensitive or primary job function is driving, The Muscogee (Creek) Nation shall not discriminate against a person in hiring, termination, or imposing any term or condition of employment or otherwise penalize a person based upon either: a. Solely, the person's status as a medical marijuana license holder; or b. Solely, the results of a drug test showing positive for marijuana and its components. B. Employees that are medical marijuana card holders shall not use, possess or be under the influence while at their place of employment or during hours of employment.
