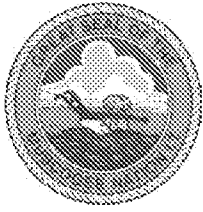

General Summary:	The Mvskoke Language Instructor will provide instruction in the Mvskoke Language to students: 6 weeks - 12 years. Activities include: planning, developing, and implementing curriculum, lesson plans/materials, in the Mvskoke Language. The instructor must work as a team member.
Principal Duties and Responsibilities:	<ol style="list-style-type: none"> 1. Must have the ability to assist in the developmental and preparation of the Mvskoke curriculum. 2. Must be able to provide Mvskoke language instruction for classroom that is age appropriate. 3. Implement basic Mvskoke language skills to the classroom staff and continue to expand from words and numbers to practical phrases. 4. Assist in training of staff through in-service and classroom participation of the Mvskoke language. 5. Provide training to parents of the children. 6. Must visit centers weekly and submit site visit report. 7. Must submit, on a monthly basis, a daily schedule detailing a work schedule for the following month to the Assistant Director. 8. Must have the ability to provide written and oral reports, including weekly reports to the Assistant Director. 9. Maintain confidentiality of program business. 10. Will assist with special events and trainings. 11. Other duties as assigned.
Minimum Requirements:	High School diploma or GED with 2 years experience. Be able to speak, read and write the language fluently. Working knowledge of grammar, office machines and computer experience. Good oral written communication skills. Applicant must have and maintain good attendance record. Must submit to and pass all necessary background checks and drug testing.
Preferred Requirements:	Bachelor degree in Curriculum Instruction. Member of the Muscogee Nation. Must have a certificate of endorsement from the Office of the Principal Chief of the Muscogee Nation showing proficiency in the Mvskoke Language. Must be computer literate.

Public Relations:

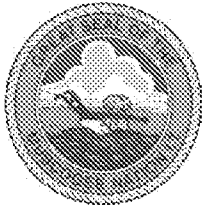

MCN Policy Requirements:

All Employees are subject to pre-employment background checks and drug testing. According to MCN Policy Section 502:Page 12/Section 503 110-111. All applicants must pass a drug test before beginning work. Any candidate who fails or refuses a drug test shall be withdrawn from employment consideration.

Medical Marijuana License Holder Protection and Non-Discrimination

A. Unless a failure to do would cause The Muscogee (Creek) Nation to imminently loose a monetary or licensing related benefit under federal law or regulations and with the exception of employees whose jobs are safety sensitive or primary job function is driving, The Muscogee (Creek) Nation shall not discriminate against a person in hiring, termination, or imposing any term or condition of employment or otherwise penalize a person based upon either: a. Solely, the person's status as a medical marijuana license holder; or b. Solely, the results of a drug test showing positive for marijuana and its components. B. Employees that are medical marijuana card holders shall not use, possess or be under the influence while at their place of employment or during hours of employment.
