If any reporting information is identical to the prior reporting period, please indicate by filling in “Same” in the information field. If any reporting information is not applicable for the report indicate by filling in “NA” in the information field. Candidates may duplicate blank copies of any pages necessary for additional reporting needs. **At least 51% of total contributions must originate from Muscogee (Creek) Citizens or businesses and organizations majority owned or controlled by Muscogee (Creek) Citizens. Campaign Finance Report requirements can be found in MCNCA Title 19 Ch. 15, § 15–103. *Campaign Finance Report*.

**Campaign contributions received prior to March 30, 2023 will be exempt from the 51% Muscogee (Creek) citizen total requirement. This is exemption will apply only for the 2023 Primary and General Election reporting periods.

DEFINITIONS PAGE

Definitions

Candidate: For the purposes of this report, candidate or candidate campaign shall mean a person who has declared his or her candidacy for elective office with the Muscogee (Creek) Nation Election Board.

Campaign contribution: For the purposes of this report, campaign contribution or contribution shall mean contribution in money, goods, or services to a candidate to whom it is offered or given with the intent that it be used in connection with a campaign for elective office.

Campaign expense: For the purposes of this report, campaign expense or expense shall mean funds spent solely for the candidate's campaign activities for elective office.

Individual: For the purposes of this report, individual shall mean a single natural person that is not a business entity, organization, or other legal entity.

Business: For the purposes of this report, business shall mean any partnership, Limited Liability Company (LLC), sole proprietorship, corporation, or other such entity.

Organization: For the purposes of this report, organization shall mean an organized body of individuals that serves a particular purpose other than the herein defined "business".

Contributor: For the purposes of this report, contributor shall mean any individual, business, or organization that donates a campaign contribution to a candidate or candidate's campaign.

Citizenship roll number: For the purposes of this report, citizenship roll number shall mean the unique identification number assigned to individuals who hold citizenship with the Muscogee (Creek) Nation. For the purposes of this report, Muscogee (Creek) Nation shall be referenced as MCN.

Campaign fundraiser: For the purposes of this report, campaign fundraiser, fundraiser, or funds shall mean any activity, function, or event held by a candidate or candidate's campaign for the purposes of generating financial support for the candidate's campaign activities for elective office.
