General Summary:	Under the supervision of the Construction Services Manager, the Inspector shall inspect rehab or modernization projects of single and multiple family dwellings. Once under contract, assure that all work is being done according and in compliance with the MCN scope of work, specifications and contract or agreement as well as any/all city, county and state codes/requirements.

Perform initial inspections of existing single and multi-family dwellings to document substandard items and define health and safety requirements.</li> <li>2. Perform inspections of rehab/modernization activities. Assess the quality of work of the contractors and adherence to the schedule and scope of work. Document any deficiencies such as poor quality of work, non-conformance to specifications, poor safety practices and lack of cleanup of the work site.</li> <li>3. Prepare and submit inspection reports as required by management, including photos of before and after phases of the projects.</li> <li>4. Review assigned work orders and discuss any concerns with the staff and/or the homeowner's if necessary.</li> <li>5. Daily review inspection log book and appointment schedule. Keep a log of locations visited.</li> <li>6. Complete and submit contract change orders with cost estimates to management for review and approval.</li> <li>7. Complete scope of work which includes material and labor cost estimates for repairs associated with the project. Review scope of work with homebuyer/owner to assure they understand the repairs to be completed. Obtain signature and leave a copy of scope with the homebuyer/owner.</li> <li>8. #### **Medical Marijuana License Holder Protection and Non-Discrimination**

A. Unless a failure to do would cause The Muscogee (Creek) Nation to imminently loose a monetary or licensing related benefit under federal law or regulations and with the exception of employees whose jobs are safety sensitive or primary job function is driving, The Muscogee (Creek) Nation shall not discriminate against a person in hiring, termination, or imposing any term or condition of employment or otherwise penalize a person based upon either: a. Solely, the person's status as a medical marijuana license holder; or b. Solely, the results of a drug test showing positive for marijuana and its components. B. Employees that are medical marijuana card holders shall not use, possess or be under the influence while at their place of employment or during hours of employment.
