Document services and assist with tracking of program outcomes. Assist clients with accessing services and resources to meet their goals. Apply best practice standards to work with youth and families in the areas of positive youth development, leadership, advocacy, etc. Ability to successfully use social media and other technology. Dress and conduct self in a professional manner befitting the position and the Muscogee (Creek) Nation. Report suspected child abuse/neglect as required by tribal, state, and federal laws. Report threats of self-harm or injuries to others as required by tribal, state, and federal laws and provide safety planning and referrals as needed. Maintain client confidentiality. A. Unless a failure to do would cause The Muscogee (Creek) Nation to imminently loose a monetary or licensing related benefit under federal law or regulations and with the exception of employees whose jobs are safety sensitive or primary job function is driving, The Muscogee (Creek) Nation shall not discriminate against a person in hiring, termination, or imposing any term or condition of employment or otherwise penalize a person based upon either: a. Solely, the person's status as a medical marijuana license holder; or b. Solely, the results of a drug test showing positive for marijuana and its components. B. Employees that are medical marijuana card holders shall not use, possess or be under the influence while at their place of employment or during hours of employment.
