Shall maintain and update all inventory/surplus. 5. Shall submit monthly reports of new equipment purchased. 6. Shall assist GSA Supervisor in planning giveaways/auctions for the purpose of disposing of surplus equipment and furniture. 7. Shall oversee all inventory /surplus received in the warehouse. 8. Shall conduct periodic inventory for other departments. 9. Shall assist the GSA office with any clerical/office duties as well as receiving and delivering as needed. 10. Must notify finance when assets are relinquished. 11. General office procedures such as addressing vendors, employees, tribal members and various inquiries. 12. Must perform any and all other duties as assigned.

#### Medical Marijuana License Holder Protection and Non-Discrimination

A. Unless a failure to do would cause The Muscogee (Creek) Nation to imminently lose a monetary or licensing related benefit under federal law or regulations and with the exception of employees whose jobs are safety sensitive or primary job function is driving, The Muscogee (Creek) Nation shall not discriminate against a person in hiring, termination, or imposing any term or condition of employment or otherwise penalize a person based upon either: a. Solely, the person's status as a medical marijuana license holder; or b. Solely, the results of a drug test showing positive for marijuana and its components. B. Employees that are medical marijuana card holders shall not use, possess or be under the influence while at their place of employment or during hours of employment.
