General Summary:	Under the supervision of the Construction Services Manager, the Inspector shall inspect modernization projects for single and/or multiple family dwellings. Prepare and cost estimate a scope of work for work needed as requested by work order. Once under contract, assure that all work is being done according and in compliance with the scope of work and contract or agreement and with the Department of Housing's specifications as well as City, County and State requirements.
Principal Duties and Responsibilities:	1. Perform initial inspections of existing single and multi-family dwellings to document substandard items and define health and safety requirements. 2. Perform inspections of rehab and/or construction related activities.  Assess the quality of work of the contractors and adherence to the schedule and scope of work. Document any deficiencies such as poor quality of work, nonconformance to specifications, poor safety practices and lack of cleanup of the work site. 3. Prepare and submit inspection reports as required by management, including photos of before and after phases of the projects. 4.  Review assigned work orders and discuss any concerns with the staff and/or the homeowner's if necessary. 5. Daily review inspection log book and appointment schedule. Keep a log of locations visited and record daily mileage. 6. Complete scope of work which includes material and labor cost estimates for repairs associated with the project. Review scope of work with homebuyer/owner to assure they understand the repairs to be completed.  Obtain signature and leave a copy of scope with the homebuyer/owner. 7.  Attend Pre-bid Meetings to answer any questions regarding scope of work. 8. Assure all materials and installation of materials are in compliance with contract terms and conditions and that all plumbing, electrical and HVAC repairs/installations comply with applicable code requirements. 9.  Complete and submit contract change orders with cost estimates to management for review and approval. 10. Perform Davis-Bacon Wage Interviews with contractors and trades workers. 11. Perform final inspections. Report any deficiencies on final inspection form and assure

#### **Medical Marijuana License Holder Protection and Non-Discrimination**

A. Unless a failure to do would cause The Muscogee (Creek) Nation to imminently lose a monetary or licensing related benefit under federal law or regulations and with the exception of employees whose jobs are safety sensitive or primary job function is driving, The Muscogee (Creek) Nation shall not discriminate against a person in hiring, termination, or imposing any term or condition of employment or otherwise penalize a person based upon either: a. Solely, the person's status as a medical marijuana license holder; or b. Solely, the results of a drug test showing positive for marijuana and its components. B. Employees that are medical marijuana card holders shall not use, possess or be under the influence while at their place of employment or during hours of employment.
