**A LAW OF THE MUSCOGEE (CREEK) NATION CREATING NEW LAW IN MCNCA TITLE 30 CHAPTER 2, ENTITLED "LEGISLATIVE DISTRICTS" TO NAME THE TULSA DISTRICT BOUNDARY JURISDICTION TO TVLSE DISTRICT**

**Be it enacted by the National Council of the Muscogee (Creek) Nation:**

**SECTION ONE. Findings. The National Council finds that:**

A. The adoption of the 1979 Muscogee (Creek) Nation Constitution, herein referred to as the Constitution, Article VI, Section 1, did not name the districts, but established the district boundaries with corresponding Oklahoma counties in which the area of district jurisdiction is located.

B. The Constitution extends to the National Council the power to legislate on any subject limited only by restrictions contained in the Constitution and laws of the United States of America and the Muscogee Constitution both contain no prohibition to name a district.

C. The Nation wishes to change the current name for the Tulsa boundary jurisdiction, "Tulsa District", to "Tvlse District" to incorporate the Muscogee language.

**SECTION TWO. NEW LAW.** The following new law shall be codified in Title 30, Chapter 2 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said new law and its inclusion in pocket parts for the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated in this law in order to be consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws; and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following new law:

**TITLE 30 NATIONAL COUNCIL/LEGISLATIVE BRANCH  
CHAPTER 2. LEGISLATIVE DISTRICTS  
SUBCHAPTER 3. TVLSE DISTRICT**

**§ 2-301. Establishment**

This law shall establish a district name for the Tulsa boundary jurisdiction, which shall hereafter, be known as "Tvlse District."


**§ 2-302. Applicability**

This name designation is solely intended for the Muscogee (Creek) Nation, and not to change county boundaries nor names for the State of Oklahoma.

**SECTION THREE. EFFECTIVE DATE.** This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

**ENACTED** by the Muscogee (Creek) National Council on this 18<sup>th</sup> day of May, 2024.
